# Parking Bulletin – what's the latest?



## Penalty Charge Notice (PCN) Pilot Scheme update:

- Royal Borough of Windsor and Maidenhead are providing a 25% discount to motorists who lose their appeal at the Traffic Penalty Tribunal (TPT) stage of the PCN process
- Elmbridge Borough Council are taking part as a comparator (not providing discount)
- Pilot began on 1<sup>st</sup> April 2016 and will run for 12 months
- First round of data was analysed in October 2016 and take up of discount so far has been minimal, possibly due to motorists paying PCNs to avoid perceived hassle of appealing
- Pilot scheme will be reviewed again in January 2017
